

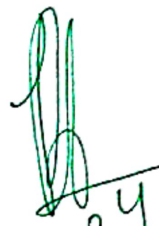
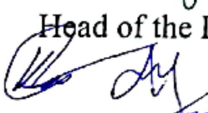

Notice

Online applications on the prescribed format available on Kashmir University website are invited from desirous eligible students of Main & Off-Site Campuses of Batch-2025 (Regular & Distance Mode) including LLM Batch-2024 (Late admission) for grant of Financial Assistance under "Students Aid Corpus Fund Scheme". Only such students whose annual family income is less than Rs 2.0 lac (Rupees two lac only) are eligible to apply for the Financial Assistance. However, preferential order for providing Financial Assistance shall be as under:-

- Orphan/s belonging to AAY Category
- Orphan/s belonging to PHH Category
- Candidates belonging to AAY Category
- Candidates belonging to PHH Category
- Candidates belonging to abandoned/broken family category

PROCEDURE/STEPS TO BE FOLLOWED:

- i) The candidates belonging from AAY/PHH category shall have to attach the latest relevant certificate/s issued by the concerned Tehsildar with the application form.
- ii) The candidates claiming financial assistance under orphan category shall attach death certificate in support of his/her claim.

The eligible students shall submit the hard copy of application form duly completed in all respects in the offices of respective Heads/Coordinators/Directors of the Departments/Centres/Campuses **on or before 29th November, 2025.**

The Heads/Directors/Coordinators of the Departments/Campuses/Centres shall forward the hard copies of applications duly recommended by Departmental Committee to the office of the Dean Academic Affairs **on or before 12th December, 2025** as per the following:

a. 1 to 25 intake	:	02 Candidates
b. 26 to 50 intake	:	04 Candidates
c. 51 to 75 intake	:	06 Candidates
d. 76 to 100 intake	:	08 Candidates
e. Above 100 intake	:	10 Candidates

Important:

- I. In order to ensure that all eligible students avail themselves of the benefits under the scheme, all Heads/Directors/Coordinators of the Departments/Campuses/Centres shall brief the students for its wider dissemination.
- II. Students who are in receipt of Financial Assistance from any Government/ Semi-Government agency are not entitled/eligible for the aforesaid Assistance.
- III. Students selected under self financed seat quota are not eligible for the Financial Assistance under SACFS.
- IV. No application, what so ever, shall be admitted after cut-off date viz 29th November, 2025.
