The following issues were discussed

Item-I:

In continuation to resolution adopted at Item-I of the Departmental Committee meeting held on 21-04-2026, the Departmental Committee resolved that CCTV cameras shall be installed in all teaching labs, research labs, open spaces, corridors and on the exterior walls of the Department for proper surveillance and same shall be purchased through GeM portal, under rules.

Item-II:

The Departmental Committee made the course allocation for FYIMP (DS & AI) 1st semester batch 2026, the classwork of which shall start from 1st July, 2026. The time-table shall be framed accordingly.

Item-III:

The Departmental Committee reviewed an application of M.Tech. CSE 3rd sem batch 2024 students requesting for conduct of CRC meeting and final examination of their 3rd semester. It was unanimously resolved that the CRC meetings of all batches of all ongoing semesters of all programmes currently offered at this Department shall be conducted as per relevant Academic Calenders already issued by the office of Dean Academic Affairs.

Item-IV:

The Departmental Committee reviewed an application of Ph.D. scholars requesting for new computer systems with upgraded configurations in research lab-II due to lack of sufficient processing capability (4 GB RAM) together with requirements of upgradation of old computer systems in the Departmental labs.

It was unanimously resolved that Computer systems in Departmental research and teaching labs shall be upgraded in terms of RAM/SSD subject to availability of funds, approved for the purpose.

Item-V:

It was unanimously resolved that research scholars having completed mandatory residential requirements shall have to handover the computer systems to the Departmental store and vacate the space allotted in research labs and accordingly, their biometric attendance shall be suspended forthwith. The list of research scholars to be vacated, in this backdrop, shall be prepared and placed before the Departmental Committee for vetting purpose.

Item-VI:

The Departmental Committee resolved that synopsis presentation of eligible research scholars for upcoming Pre-BORS shall be held on 08-07-2026 before the Departmental Committee.

Item-VII:

The Departmental Committee deliberated upon the closure of 2nd Local fund bank account of the Department. It was unanimously resolved that only one Local fund account shall be maintained in the Department and accordingly, all funds from the 2nd Local fund bank account shall be utilized in tune with the budgetary allocations & approvals under the approved Budget Head local fund.

Item-VIII:

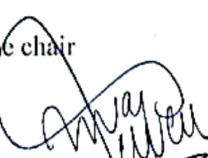

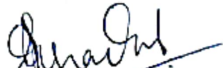
