The following issues were discussed: -Item-I

The DRC reviewed the Ph.D. evaluation report of one scholar namely Ms. Nahida Shafi under the supervision of Dr. Manzoor A. Chachoo wherein one of the experts/evaluators has recommended for "accepting the Ph.D. thesis with minor revision". The same remarks were shared with the concerned supervisor & scholar. In light of the comments made by the expert/evaluator, response from the said scholar was reviewed by the DRC along with recommendation of her supervisor.

It was unanimously resolved that the revised thesis (soft copy) along with reply to each expert comment shall be shared with the concerned evaluator via email by the HOD, seeking his/her fresh remarks in light of the revisions made. The Department shall proceed accordingly in the matter, upon receipt of the expert's recommendation.

Item-II

NOTES

The DRC reviewed the applications regarding cancellation of the Ph.D admission of 02 candidates namely Ms. Mehak Bhat who joined on 05-03-2025 under the supervision of Dr. Sajad Mohd Khan and Mr. Tufail Irshad who joined on 27-01-2025 under the supervision of Prof. M. Arif Wani.

The DRC unanimously resolved that the requests for cancellation of Ph.D admissions in these two cases be forwarded to Dean Research for further necessary action under rules. Moreover, DRC recommends refund of deposited Ph.D admission fee under rules in their case.

Item-III

The DRC reviewed the application for grant of Registration for supervising Ph.D. students in the discipline of Computer Science submitted by Dr. Abid Sarwar, Assistant Professor of this Department. The DRC noted that the said faculty member has been supervising Ph.D students at his erstwhile affiliation. i.e, University of Jammu, Bhaderwah Campus and already having a substantive experience of Eight years at the same University. Moreover, the said faculty member has seven SCIindexed journal publications and a DBT/DST funded research project.

In this backdrop, the DRC unanimously recommends grant of registration for Ph.D supervision in favour of Dr. Abid Sarwar, in anticipation of the approval of the BORS. Item-IV

The DRC reviewed applications regarding re-registration of two Ph.D scholars namely Mr. Shahnawaz Qadir and Mr. Rayees Ahmad Dar, both under the supervision of Dr. Rana Hashmy, Ex-Scientist-C, of this Department.

The DRC remarked that further course of action in the matter shall be taken after the notice is served to the student
