As discussed by department: After admission to the Ph.D Programme the Ph.D scholars should follow the following guidelines:

1. First 6 months : Course Work
2. Second 6 months : Prepare Synopsis

3. After 12 months : Submission of Synopsis to DRC

4. After 18 months : RPAC I will be conducted, no publication

is required.

5. After 24 months : RPAC II will be conducted, atleast one

conference paper is required.

6. After 30 months : RPAC III will be conducted, second conference

paper is required.

7. After 36 months : RPAC IV, journal publication is required as per

University guidelines. RPAC IV will be conducted only after BORS has been conducted for the scholars.

#### ITEM II: Finishing I.Ph.D with M.Phil degree (Younis Ali).

Application of scholar Younis Ali to exit Ph.D was received, DRC recommends Ph.D scholar is allowed to exit and submit the M.Phil Dissertation as per university rules.
