The following issues were discussed: -

The admission process to Ph.D programme 2024 was carried out for the eligible candidates under exempted category (UGC/CSIR/ICAR-NET/JRF, SET/GATE/M.Phil). Out of four candidates who appeared in the interaction in front of the DRC, two candidates namely Gulba Din Mapnoo (Form No. 24701190) and Zayeem Ahmad Shiekh (Form No.24701254) did not submit evidence (Marks cards/Degree certificates) of having successfully qualified their Master's degrees. As such, it was resolved that these two candidates are not eligible for admission to the Ph.D programme. Out of the remaining two candidates, the DRC provisionally selected the following candidate for Ph.D programme based on performance and research interests and assigned the registered Supervisor to him as indicated below:
