- Number of project with Principal Investigator(PI) should not exceed one (1).
- Fresh research proposals can be considered only when the on-going project/survey is about to conclude.
- Eligible PI in the project/survey proposals should not exceed two(02).
- PI and Co-PIs must be employee but not a research scholar.
- International travel if any, is not permitted under the programme.
- The overhead expenses will be given 10% of the yearly budget excluding the cost of permanent equipment.
- The Investigators should clearly understand and accept the Terms and Conditions regulating the grants released by the JKST&IC.
- Funds for approved proposals will be released only as per rules of the JKST&IC.
- Publication of results/presentation of papers should clearly acknowledge the funding from the JKST&IC, UT of J&K and should also contain a disclaimer that the JKST&IC is not responsible for any result interpretations expressed in the report/study.
- On the completion of any study/survey/research project, PI must submit Utilization Certificate ,Project/ Study/Survey report , and other relevant documents duly authenticated by the competent authority to JKST&IC

In addition to above, the SAC has advised to seek a revised budget estimate within the amount recommended by the committee (as per format attached). The amount recommended is **Rs 01.50 lacs** for the survey/study titled: **Impact of Online Education in Kashmir During Covid-19: Strategic Intent Study (PI - Dr Manzoor Ahmed Chahoo,Scientist -D Deptt of Computer Sciences,University of Kashmir)**.The information, duly signed,being sought on the below given format, may be submitted through **return mail by 15thth of March 2021 upto 5.00 PM** positively failing which the survey/study project shall not be taken up for funding.
