Item-I:




Upon reviewing the fresh evidence furnished by the scholar, the committee noted that:

- The technical review of the publication is satisfactory.




The following issues were discussed: -


Item I:


The Committee reviewed the journal publication by Ph.D. scholar namely Mr. Rayees Ahmad Dar under supervision of Dr. Rana Hashmy titled "Fake News Detection in Social Media using Cross and Bi-encoders-based approach" which was considered for RPAV IV presentation held on 27-02-2023 in the Department. The RPAC committee observed that the said journal publication does not have appropriate technical reviews which can be considered adequate and the publication is not in the UGC care list. The published paper is not indexed in Scopus/WOS either.


As such the RPAC committee unanimously resolved that the said scholar shall have to re-appear in RPAC IV, after furnishing the evidence of a fresh journal publication that meets the research statues prescribed by the University. Consequent upon this, the RPAC IV certificate dated: 27-02-2023 is hereby withdrawn forthwith and ab initio.




