4. One Senior Faculty Member from each Department -**Member**
5. One Senior Female Faculty Member (to be nominated) -**Member**
6. One Non-Teaching Staff Member (to be nominated) -**Member**
7. One Research Scholar **Member**
8. One Student Representative (3rd Semester Male) -**Member**
9. One Student Representative (3rd Semester Female) -**Member**

Provided that wherever a Department / Centre / Satellite Campus is unable to fulfill the above composition in entirety, the DIQA Unit may be constituted appropriately within the available options.
