

It is notified for the information of all concerned that on the basis of the recommendations of the committee constituted for the purpose and in anticipation of the approval of the competent bodies, the Vice-Chancellor has been pleased to authorize the following addition/modification in the Statute 9.1 governing Post-graduate Scholarships:

- i. That students of M.Tech programme shall also be entitled for award of one merit and one merit cum means scholarship as per Statute 9.1, of the statutes governing Post Graduate Scholarships.
- ii. The merit cum means scholarship shall be awarded on the basis of merit among the following categories of students:
 - Orphan/s belonging to AAY Category
 - Orphan/s belonging to BPL Category
 - Candidates belonging to AAY Category
 - Candidates belonging to BPL Category
 - Candidates belonging to abandoned/broken family category
 - Poor/financially weaker categories

In the case of Non-AICTE approved M.Tech programmes where GATE qualified students do not get AICTE scholarships, GATE qualified students shall be preferred over students who have got admission on the basis of entrance test for grant of merit scholarship.
